Old Business

- 1. Voted on September Meeting Minutes-Approved
- 2. Re-Opening Plan Status Update
 - Per Mr. Orebaugh, face-to-face return for Option 1 students has been going smoothly
 - School safety guidelines changing frequently (ex: singing), everyone is doing their best to abide by them
 - Dr. Reddy shared that 15 garden plots have been assigned to teachers to use this year, great opportunity to learn outside
 - Picture Day will proceed on 10/29 and 10/30 (Option 2 students able to come in evenings from 4-6pm their pics if they would like to)
 - The Den will be sent out every other week, next week's will have a great deal of important information
- 3. Membership Update
 - 106 members to date (70 parents, 36 staff)
 - discussed incentives for staff to join including fun contest by grades for small prizes
- 4. Room Parent Update
 - All Room Parents in place with the exception of 3 classrooms (two Virtual classes, one in-person)
 - Room Parent Orientation Training successfully took place on 9/29
 - No food, candy or drinks permitted to be sent in for celebrations at this time (including food that would be sent home, still not allowed)
 - Non-food items are allowed to be donated/sent in at the teacher's discretion
 - In the future, admin may consider the possibility of classes purchasing treats from cafeteria to be eaten at the end of lunch (class parties only, not individual birthdays)
- 5. Spirit Wear Update
 - Website is live for ordering through 10/30
 - Short-sleeve, long-sleeve and sweatshirts offered
 - Recent switch in style of short-sleeve shirts to ensure more standardized sizing
- 6. Reflections Contest
 - Contest underway through 10/28
 - All entries DIGITAL only
 - Mrs. Eisenberger, Art Teacher, may be interested in assisting with contest
- 7. Bylaws Update
 - Bylaws voted on and approved by Board and in General Membership Meeting on 10/5
 - Mailed to VA PTA for final approval
 - VA PTA will mail back final copy for our records
 - Next update: October 2025

New Business

- 1. 2020 Holiday Lights at the Beach
 - Board discussed presentation slides distributed by VBPTA about this program
 - Voted to proceed with offering this discount/sale to TOES families and staff this holiday season
 - Molly will reach out to contact to proceed with preparing for sale
- 2. Additional Budget Expenditures for 2020-2021
 - Principals did not have any additional staff members asking for funds to be allotted to them for any further needs this year
 - Kindergarten reached out to Molly and Milissa to inquire about funding to purchase 53 pumpkins (one per Option 1 student currently in-person) for 10/30 project
 - Board approved \$130 addition for this
 - Recap provided of \$600 approved last month to help Library replace books never returned after Spring Closure
 - Mrs. Dibbs has submitted requests for those, Molly completed purchase
